WARRANTY DEED

Richard E. Redden and Emma P. Redden, his wife, grantors, of Hoytsville, Summit County, State of Utah, hereby conveys and warrants to Summit Stake Corporation of the Church of Jesus Christ of Latter-Day Saints, a corporation sole, created and existing under and by virtue of the Laws of the State of Utah, in the County of Summit, State of Utah, grantee, for the sum of nine thousand dollars (\$9,000.00), the following described tracts of land situated in the County of Summit, State of Utah:

Tract 1. Beginning at a point that is 321.75 feet South from the Northwest corner of the southwest quarter of Section 27, Township 2 North, Range 5 East of the Salt Lake Base and Meridian, and running thence South 89°15' East 1281.64 feet; thence South 0°18' West on the forty line 563.85 feet; thence South 89°05' East 1277.5 feet; thence South 89°31' East 2640 feet; thence South on the Section line 1064.25 feet; thence North 89°48' West 2640 feet; thence North 88°48' West 2542.3 feet; thence North on the Section line 666.875 feet; thence North 89°30' West 604.5 feet; thence North on the Section line 562.8 feet to the place of beginning, containing 138.13 acres, more or less.

Tract 2. Beginning 4.75 rods North of the Southeast corner of the northeast quarter of the southeast quarter of Section 28, Township 2 North, Range 5 East, of the Salt Lake Base and Meridian, and running thence North 21.12 rods, thence West 62.08 rods; thence South 1°49'

East 22.02 rods; thence East 55.36 rods to the place of beginning, containing 7.75 acres, more or less.

Tract 3. Beginning at a point that is 1.19 chains North from the Southeast corner of the Northeast quarter of the Southeast quarter of Section 28, Township 2 North, Range 5 East of the Salt Lake Base and Meridian, and running thence West 9.78 chains; thence South 20° West 4.558 chains; thence South 0.698 chains; thence East 11.40 chains to the Section line; thence North 5.0 chains to the place of beginning, containing 5.82 acres, more or less.

Tract 4. Beginning at a point 19.52 rods South of the Northeast corner of the Northeast quarter of the Southeast quarter of Section 28, Township 2 North, Range 5 East of the Salt Lake Base and Meridian, and running thence South 82°30' West 71.36 rods; thence South 18°48' East 26.56 rods; thence East 62.08 rods; thence North 34 rods to the place of beginning, containing 12.39 acres, more or less.

There is excepted and excluded from the above land the following described tracts of land, to-wit:

a. A tract of land beginning at a point which is 9.78 chains West of a point that is 1.19 chains North from the Southeast corner of the Northeast quarter of the Southeast quarter of the above described Section 28, and running thence West 4.06 chains to the State Highway; thence North 18°48' West 1.535 chains; thence East 4.75 chains; thence South 7°41' West 1.466 chains to the place of beginning, containing 0.64 an acre, more or less.

b. Also, a tract of land 0.5 chains wide from the Meeting-House Lot to the Cemetery, described as follows: Beginning at a point that is 0.34 chains North from the Southeast corner of the northeast quarter of the southeast quarter of said Section 28, and running thence North 0.5 chains; thence South 85°17' West 10.014 chains; thence South 20° West 0.54 chains; thence North 85°17' East 10.20 chains to the place of beginning, containing 0.5 acres, more or less.

c. Also, a tract of land beginning at a point which is North 48.84 rods and West 26.83 rods from the southeast corner of the northeast quarter of the southeast quarter of the above Section 28, and running thence South 83°05' West 39.32 rods; thence North 18°48' West 3.07 rods; thence north 83°05' East 39.32 rods; thence South 18°48' East 4.07 rods to the place of beginning, containing one acre, more or less.

d. Also, a tract of land beginning at a point which is North 85 rods and West 35.4 rods from the Southeast corner of Section 28, Township 2 North, Range 5 East of the Salt Lake Base and Meridian, and running thence North 7°41' East 7 rods; thence West 22 rods; thence North 18°48' West along the State Highway 15.3 rods; thence North 76°11' East 36.7 rods; thence South 12°23' West along the East Bank of the Hoytsville Irrigation Ditch No. 1, a corporation, 12.1 rods; thence South 11°04' West along said East Ditch Bank, a distance of 6.6 rods; thence South 23°56' West along said West Ditch Bank, a distance of 12.9 rods to the point of beginning, containing 3.45 acres, more or less.

e. Also, a tract of land beginning 78.54 feet North and 645.48 feet West of the Northeast corner of the Southeast quarter of the Southeast quarter of Section 28, Township 2 North, Range 5 East of the Salt Lake Base and Meridian, and running thence South 20°00' West 300.82 feet; thence South 46.06 feet; thence East 124.92 feet to the West Bank of the Hoytsville Irrigation Ditch No. 1, a corporation; thence along the West Bank of said Ditch North 12°00' East a distance of 123.42 feet; thence North 30°05' West 44.22 feet; thence North 38°45' West 48.84 feet; thence North 17°00' West 23.76 feet; thence North 13°50' East 35.64 feet; thence North 46°00' East 43.56 feet; thence North 11°30' East 46.20 feet; thence West 37.8 feet to the point of beginning, containing 0.56 acres, more or less.

The granted premises less the exceptions containing 157.84 acres, more or less.

There is conveyed herewith the improvements on said land and the water and water rights appurtenant thereto, particularly including 4½ shares of the capital stock of the Hoytsville Irrigation Ditch No 1, a corporation, and 87 shares of the Capital stock of the Elkhorn Ditch Company, a corporation, and any other water and water rights, reservoir and reservoir rights of the grantors appurtenant to or used in connection with the irrigation of the granted premises. Also one share of the Capital stock of the Hoytsville Pipe Water Company, a corporation.

The grantors agree to executed any further assurances necessary to convey or assure the title to the above granted property and premises.
