AMENDMENT TO THE DECLARATION OF CONDOMINIUM

OF

CORNER STONE CONDOMINIUMS

PHASE I, II, III, IV, V, and VI

THIS AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF CORNER STONE CONDOMINIUMS (hereinafter "the Amendment to the Declaration"), is made by JAMES JOYNER (hereinafter collectively "the Declarant).

RECITAL

WHEREAS, on the 9th day of October 1990, that certain instrument captioned "Declaration of Condominium of Corner Stone Condominiums" (therein and herein "The Declaration"), consisting of 42 pages, including Exhibits "A", "B", and "C", thereto attached, was filed for record by the Declarant in the office of the County Recorder of Utah County, Utah, in Book 2730, page 363 as Entry No. 33579, Corner Stone Condominiums, hereinafter recited reference is hereby made for all purposes; and

WHEREAS, that certain instrument captioned "Record of Survey Map of Corner Stone Condominiums, "prepared by Dudley & Associates and certified by Roger Dudley, Utah registered land surveyor, professional engineer, was filed of record simultaneously with the Declaration by the Declarant in said Office of the County Recorder as Entry No. 33518, assigned Map Filings No. 4059; and

WHEREAS, the Declaration (in Article IV) expressly reserved to the Declarant the right to expand the Corner Stone Condominiums, Condominium Project ("the Project"), which right included the method of expansion, the right to adjust percentages of Common Areas and other provisions relative thereto as all therein set forth; and

WHEREAS, the Declarant now proposes to expand the project pursuant to the provisions of said Article IV of the Declaration to encompass the tracts of land hereinafter described, NOW, THEREFORE, the Declarant hereby certifies and declares as follows:

SUPPLEMENTARY DECLARATION

- 1. Expansion of Definitions. The definitions used in the Declaration (wherever the context so admits as applied to the Amendment to the Declaration) shall be so expanded to encompass and refer to the project as hereby expanded.
- 2. <u>Submission of Additional Tracts to Condominium Project</u>. the Declarant hereby submits the following described tracts of land in the County of Utah (hereinafter sometimes referred to as "Phase VII"), to-wit:

Phase VII

Commencing at a point located N89 degrees 27'18" W along the section line 315.08 feet and south 97.11 feet from the north 1/4 corner of Section 14, Township 6 South, Range 2 East, Salt Lake Base and Meridian; thence North 89 degrees 59'12" East 133.52 Feet, thence South 00 degrees 35'54" East 99.69 feet, thence South 89 degrees 23'20" East 27.47 feet, thence South 00 degrees 50'40" East 131.26 feet, thence South 89 degrees 37'37" West 109.05 feet along Phase IV Cornerstone Condominums, thence North 00 degrees 59'41" West 51.53 feet, thence arc length 80.61 feet CHD.Bears N49 degrees 06'11" West 71.46, R=48.00'. Thence North 133.60 feet Along phase VI Cornerstone Condominimums, to Point Of Beginning.

Area = 0.69 acre.

including all buildings and other improvements constructed thereon, together with all appurtenances thereto, and subject to all the covenants, conditions, and restrictions as hereinafter provided, to the Provisions of the Utah Condominium Ownership Act, so that such additional Buildings, Improvements and Appurtenances and the initial Condominium Project created by the Declaration shall in every respect be treated as integral parts of a single condominium ownership Project.

- 3. Name. The phase VII lands, buildings, improvements and appurtenances hereby submitted to the provisions of the Act shall be known as Corner Stone Condominium, Phase VII.
- 4. <u>Development Plans</u>. This Phase, constituting expanded area of the Project will include the two (2) buildings containing a total of four (4) units, as shown on the supplemental record of survey map (the supplemental map), prepared and certified by Roger Dudley, engineer, which is filed simultaneously herewith.
- 5. Proportionate Ownership in Common Areas. The Phase VII unit owners' proportionate ownership in the common areas of the Project as expanded, shall be set forth in Exhibit "A", hereto attached and made a part hereof. The expanded project will be managed, treated and governed in all respects as one condominium project without regard to phases, it being intended that references to phases in the Declaration and herein being made are for convenience only. The provisions of Article VII of the Declaration reserving to Declarant the right to adjust percentages of common areas of the original condominium shall likewise apply to the Phase VII area.
- 6. Amendment of Ownership of Unit Owners of Phase VII in the Common Areas. Pursuant to the provisions of Article VII of the Declaration reserving to Declarant the right to adjust the percentages of the Unit Owners; ownership in the common area upon the project being expanded, the Declarant hereby declares and certifies that from and after the recordation hereof in the Office of the County Recorder of Utah County, Utah, the proportionate ownership of unit owners of Phase VII in the common areas of the Project, as expanded, shall be as set forth in the part of said Exhibit "A", captioned "Phase VII--Amended Percentages of Ownership in the Common Areas."
- 7. Area of Land Covering the Project After Expansion. The Project as expanded here by encompasses the following described tracts of land in Utah County, Utah, to-wit:

CORNER STONE CONDOMINIUMS PHASE I

Being the perimeter description of Phase II, Cornerstone Condominiums, Orem, Utah.

Thence North 133.60 feet Along phase VI Cornerstone Condominimums, to Point Of Beginning.

Area = 0.69 acre.

Being the perimeter description of Phase VII, Corner Stone Condominiums, Orem, Utah.

8. Incorporation by Reference of this Declaration. All and singular the provisions of the Declaration of Condominium of Corner Stone Condominiums, together with the Bylaws, wherever the context so admits as applied to Phase I area, are hereby adopted herein by reference and made a part hereof as if the same were fully set forth herein.
