NOW, THEREFORE, IT IS RESOLVED that the following policy is hereby adopted by the Association:

A transfer fee shall no longer be charged or due upon the sale or conveyance of a Unit. Section 6.06(e) of the Bylaws shall no longer be carried out or enforced by the Association, its directors, officers, agents or employees, and no seller, buyer, title company or other person or entity shall be liable or responsible for payment of any transfer fee to the Association as a result of a sale or conveyance of a Unit.
