## SUBORDINATION AND NON-DISTURBANCE AGREEMENT

This Subordination and Non-Disturbance Agreement ("Agreement") is made and entered into this 4th day of 500 201, by and among Mountain West Small Business Administration, as agent for the US Small Business Administration having a mailing address of 2595 East 3300 South, Salt Lake City, UT 84109 ("Lender") and CommNet Cellular Inc. d/b/a Verizon Wireless as successor in interest to Cellular Inc. Network Corporation, having a mailing address of 180 Washington Valley Road, Bedminster, New Jersey 07921 ("Grantee") (each, a "Party" and collectively, the "Parties").

## WITNESSETH:

WHEREAS, Lender has extended financing and/or credit, and may hereafter extend financing and/or credit to, Cedar Storage Partners, LLC (hereinafter known as "Grantor"), secured in whole or in part, by the following mortgages:

 That certain Deed of Trust, Fixture Filing and Assignment of Rents by and between Grantor as Trustor and Lender as Trustee dated May 10, 2021 in the principal amount of Five Million Four Hundred Ninety-Nine Thousand and No/100 Dollars (\$5,499,000.00) and recorded with the Iron County Recorder, Utah on May 12, 2021 at Book 1550, Page 1179.

as the same may have been modified from time to time (all documents being collectively referred to as the "Mortgage") encumbering certain property owned by Grantor as more fully described in <u>Exhibit A</u> attached hereto and by this reference made a part hereof (the "Property");

WHEREAS, Grantor (or its predecessor-in-interest) and Grantee (or its predecessor-in-interest) entered into that certain Land Lease Agreement dated November 24, 2003, a memorandum of which was recorded in Book 1343, Page 1105, in Iron County, Utah (as it may be amended or modified from time to time, the "Lease"), pursuant to which Grantor leases a portion of the Property to Grantee;

WHEREAS, Lender has required that the Lease be made subordinate to the lien of the Mortgage and Grantee has required that its rights under the Lease not be disturbed as a result of a foreclosure or the other exercise of mortgagees remedies under the Mortgage;

WHEREAS, Grantee, Verizon Communications Inc., a Delaware corporation, and other parties identified therein, entered into a Management Agreement and a Master Prepaid Lease, both with an effective date of March 27, 2015 and both with ATC Sequoia LLC, a Delaware limited liability company ("American Tower"), pursuant to which American Tower subleases, manages, operates and maintains, as applicable, the Leased Premises (as defined in the Lease), all as more particularly described therein; and,

WHEREAS, Grantee has granted American Tower a limited power of attorney (the "POA") to, among other things, prepare, negotiate, execute, deliver, record and/or file certain documents on behalf of Grantee, all as more particularly set forth in the POA.

**NOW THEREFORE**, in consideration of the mutual promises and covenants contained herein, the receipt and sufficiency of which are hereby acknowledged and intending to be legally bound, the Parties agree as follows:

- 1. <u>Subordination of Interests</u>. The Lease and all of Grantee's right, title and interests thereunder shall be subordinate to the lien of the Mortgage.
- 2. Consent. Lender hereby consents to the Lease and agrees that: (i) the Lease remains in full force and effect; (ii) the Lease and all of Grantee's rights under the Lease shall not be terminated, diminished, disturbed or affected in any manner by Lender's foreclosure of the Mortgage or a transfer to Lender by deed-in-lieu of foreclosure or otherwise; and, (iii) Grantee shall not be named as a defendant in any foreclosure action or proceeding except to the extent required pursuant to applicable law. If requested by Grantee, Lender or its transferee by deed-in-lieu of foreclosure or otherwise shall enter into a new lease agreement following any such foreclosure or other succession event on the same terms and conditions as the Lease for the purposes of confirming that the Lease continues in full force and effect regardless of applicable law.
- 3. <u>Grantee's Personal Property</u>. Lender acknowledges that provisions of the Mortgage and/or any related documents shall not apply to any equipment owned or leased by Grantee which is now or may hereafter be placed on the Property and Grantee is authorized to remove said equipment in accordance with the terms of the Lease.
- Binding Effect. This Agreement shall be binding upon and inure to the benefit of the Parties hereto and their respective heirs, executors, administrators, personal representatives, successors and assigns.
- 5. Notices. All notices or demands which are required or permitted to be given or served hereunder shall be in writing, and shall be deemed to have been given or served: (i) by hand delivery, on the date of hand delivery; (ii) one (1) business day after delivery to an overnight courier for next business day delivery, delivery charges prepaid; or, (iii) by

registered or certified United States Mail, postage prepaid and return receipt requested, three (3) days after deposit in the mail, addressed as follows:

Inability to deliver notice due to a change of address for which no notice was given, or refusal to accept delivery, shall be deemed delivery hereunder.

- 6. Governing Law. This Agreement shall be governed by and construed in all respects in accordance with the laws of the state or commonwealth in which the Property is situated, without regard to the conflicts of laws provisions of such state or commonwealth.
- 7. <u>Captions</u>. The captions and headings used in this Agreement are for convenience only and do not in any way restrict, modify or amplify the terms of this Agreement.
- 8. <u>Counterparts</u>. This Agreement may be executed in several counterparts, each of which when so executed and delivered, shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument, even though all Parties are not signatories to the original or the same counterpart. Furthermore, the Parties may execute and deliver this Agreement by electronic means such as .pdf or similar format. Each Party agrees that the delivery of the Agreement by electronic means will have the same force and effect as delivery of original signatures and that each Party

may use such electronic signatures as evidence of the execution and delivery of the Agreement by all Parties to the same extent as an original signature.
