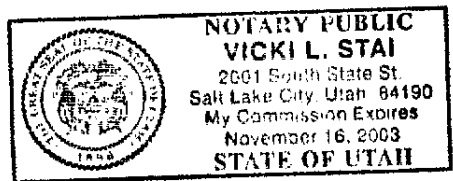
Especially note Section 20.4.
