- 1. The DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS of NORTHFIELD TOWNHOMES OWNERS' ASSOCIATION dated January 16, 2019 (the "Declaration") was recorded in the Office of the Recorder of Iron County, Utah on January 16, 2019 as Entry No. 00724058 in Book 1434 beginning at Page 513.

Pursuant to the Declaration, the Reinvestment Fee shall belong to the Association, and the purpose of the Reinvestment Fee is to benefit the Property, including payment for common planning, facilities and infrastructure, obligations arising from an environmental covenant, community programming, resort facilities, open space, recreation amenities, charitable purposes or association expenses.

- 8. The Reinvestment Fees paid under the Declaration are required to benefit the Property.
- 9. The Reinvestment Fee (as more specifically set forth and described in the Declaration) is the only reinvestment fee covenant to burden the Property, and no additional reinvestment fee covenant of any type or kind may be imposed on the Property.
