ed as follows:

Beginning on the south boundary line of the Grantor's land at a point 1628.3 feet west, more or less, from a county brass cap marking the Southeast corner of Section 4, Township 9 North, Range 2 West, Salt Lake Meridian, and running thence North 9°15' West 1382 feet, more or less, to the north boundary line of said Grantor's land; thence East 172.3 feet, along said north boundary line; thence South 9°15' East 1382 feet, more or less, along a line which
