- F. In case of any conflict between the terms of this Amendment and the terms of the Declaration, the provisions of this Amendment shall control.
- G. Pursuant to Article 14, Section 14.1(a) of the Declaration, the Declarant has the sole authority to amend the Declaration during the Period of Declarant Control.
- H. As of the date of the recording of this First Amendment, the Period of Declarant Control remains in effect.

AMENDMENTS

NOW THEREFORE, in consideration of the foregoing Recitals, the Declarant hereby executes this First Amendment, which shall be effective as of its recording date with the Utah County Recorder's office.

- (1) <u>Amendment No. 1</u>. Article III, Section 3.7 of the Bylaws as Exhibit "B" to the Declaration shall be replaced in its entirety with the following:
 - 3.7 **Quorum**. At any Owner meeting, the number of Owners present, either in person or by proxy shall constitute a quorum for the transaction of business.
