Beginning at fence on east boundary line of grantors land at a point 790 feet south and 1320 feet east, more or less, from the west quarter corner of Section 19, T. 2 S. R. 6 E. S.L.B.&M. then e running S. 80°12' W. 1352 feet to fence on west boundary line of said land and being in Lot 3 of said Section 19.

Excepting from the above that part of the line on or over County Road.

This easement will terminate November 1, 1954.
