WASHINGTON COUNTY, a body corporate and politic of the State of Utah, GRANTOR, hereby quitclaims to
FRANK A. TERRY, GRANTEE, of Enterprise, Wash-
ington County, Utah, for the sum of One (\$1.00) Dollar and other adequate consideration, the following described
tract of land in Washington County, State of Utah, to-wit:

Beginning at a point 14 rods East of the Southwest corner of the SW^{1/4} of Section 1, Township 37 South, Range 17 West, Salt Lake Meridian, and running thence thence the SW^{1/4} of said Section 1; thence South 80 rods; thence East approximately 12 rods to beginning, containing 6.6 acres, more or less;

Together with all improvements thereon and all appurtenances thereto belonging.

WHEREAS, the foregoing property was sold to Washington County at Preliminary Sale on January 10, 1910, as appears in Book 2, of the 1939 Tax sale records of Washington County, at Page 382, and that on the 17th day of May, 1914, the fee simple title to said property vested in the said County of Washington by Auditor's endorsement of Tax Deed, and

WHEREAS, Washington County, by Tax Deed dated October 11, 1949, filed for record October 11, 1949, at 1 P.M., and recorded in Book N-4 at Page 503 of the records of Washington County, Utah, conveyed the property intended to be assessed and sold by said Preliminary Tax Sale and Auditor's Endorsement of Tax Deed, but the description of said property as set forth in said Tax Sale and Auditor's Endorsement of Tax Deed did not conform to the description of said tax deed dated October 11, 1949, and

WHEREAS, the said County of Washington desires to quitclaim to the said grantee in the Tax Deed dated October 11, 1949, Frank A. Terry, all its right, title, and interest in and to the said property described in the preliminary tax sale and Auditor's Endorsement of Tax Deed. WHEREAS, Owen Cottam St. George, of the County of Washington State of Utah heretofore purchased from the State of Utah, the lands hereinafter described, pursuant to the laws of said State in such case made and

provided,

AND WHEREAS, the said Owen Cottam has paid for said lands, pursuant to the conditions of said sale, and the laws of the State duly enacted in relation thereto, the sum of One Hundred and no/100 (\$100.00) Dollars, and all legal interest thereon accrued, as fully appears by the certificate of the proper officer, now on file in the office of the Secretary of State of the State of Utah;

NOW THEREFORE, I Heber Bennion, Jr. Acting, Governor, in consideration of the premises, and by virtue of the power and authority vested in me by the laws of the State of Utah, in such case made and provided, do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said Owen Cottam and to his heirs and assigns forever, the following piece or parcel of land, situate in the County of Washington State aforesaid, to-wit: The Northwest Quarter (NW₄) of the Southwest Quarter (SW₄) of Section Sixteen (16), Township Forty-three (43) South, Range Fifteen (15) West, of the Salt Lake Meridian,

Rights of way for canals, ditches, tunnels, telephone and transmission lines constructed by authority of the United States are hereby reserved. U. S. Act, Aug. 30th, 1890 (26 Stat. 39); 86-2-3 Utah Code Annotated 1943.

containing Forty and no/100 (.40.00) acres according to the said certificate.

TO HAVE AND TO HOLD the above described and granted premises unto the said Owen Cottam and to his heirs and assigns forever, subject to any easement or right of way of the public, to use all such highways as may have been established according to law, over the same or any part thereof, and subject also to all rights of way for ditches, tunnels, and telephone and transmission lines that may have been constructed by authority of the United States.
