DEED

Ida M. Bamberger, grantor, of Salt Lake City, Salt Lake County, Utah, hereby conveys to the Salt Lake & Ogden Railway Company, a corporation, grantee, of the same place, for the sum of Fifty dollars, a perpetual easement for right of way for railroad purposes over and across the following described tract of land situated in Weber County State of Utah, to-wit:

Beginning at a point which bears South 42° 04' East 999.5 feet, from the Northwest corner of the Northeast Quarter of Section 6, Township 5 North, Range 1 West, Salt Lake Meridian; running thence South 69° 45' East 265.6 feet; thence South 23° East 175 feet; thence North 57° 42' East 680.5 feet; thence North 207.8 feet; thence South 74° 15' West 755.7 feet; thence South 55° West 197.7 feet to the place of beginning, now used by the said grantee as a right of way for its railroad over and along the same.
