RIGHT-OF-WAY AND EASEMENT GRANT

Land of Grantor located in the Southeast Quarter of Section 22, Township 3 South, Range 1 West, Salt Lake Base and Meridian;

TO HAVE AND TO HOLD the same unto said QUESTAR GAS COMPANY, its successors and assigns, so long as such facilities shall be maintained, with the right of ingress and egress to and from said right-of-way to maintain, operate, repair, inspect, protect, remove and replace the same.
