**FIFTH AMENDMENT  
TO THE  
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS  
AND BYLAWS OF PROSPECTOR SQUARE CONDOMINIUMS**

This Fifth Amendment To The Declaration Of Covenants, Conditions And Restrictions and Bylaws Of Prospector Square Condominiums, hereinafter referred to as the "Fifth Amendment", is made and executed this 21 day of February, 2008, by Prospector Square Condominiums Association of Unit Owners, acting by and through the Management Committee (the "Association"). Any capitalized terms used but not defined herein shall have the meanings attributed to them in the Declaration Of Covenants, Conditions And Restrictions Of Prospector Square Condominiums, recorded in the official records of Summit County on August 2, 1978, as Entry No. 148128, Book No. M117, Pages 249-283 (together with the First Amendment (defined below), the Second Amendment (defined below), the Third Amendment (defined below) and the Fourth Amendment defined below, the "Declaration").

**RECITALS**

A. A First Amendment to the Declaration Of Covenants, Conditions And Restrictions Of Prospector Square Condominiums was previously recorded in the official records of Summit County, Utah on August 11, 1978, as Entry No. 148407, Book No. M117, Pages 724-727 (the "First Amendment").

B. A Second Amendment to the Declaration Of Covenants, Conditions And Restrictions Of Prospector Square Condominiums was previously recorded in the official records of Summit County, Utah on December 8, 1978, as Entry No. 148407, Book No. M124, Pages 403-417 (the "Second Amendment").

C. A Third Amendment to the Declaration Of Covenants, Conditions And Restrictions Of Prospector Square Condominiums was previously recorded in the official records of Summit County, Utah on May 10, 1979, as Entry No. 155665, Book No. M133, Pages 8-10 (the "Third Amendment").

D. A Fourth Amendment to the Declaration Of Covenants, Conditions And Restrictions Of Prospector Square Condominiums was previously recorded in the official records of Summit County, Utah on August 7, 1981, as Entry No. 182368, Book No. 195, Pages 223-225 (the "Fourth Amendment").

E. A First Amendment to the Bylaws of Prospector Square Condominiums was previously recorded in the official records of Summit County, Utah on July 20<sup>th</sup> 2006.

F. The Association, by a vote of at least 67% of the total voting power of the Association at a meeting of the membership held on March 15, 2008 adopted this Fifth Amendment and did duly authorize and approve its signing and recording by the Management Committee.

G. The purpose of this Fifth Amendment is to clarify that any damage to the Property caused by a Unit Owner (or his family, tenant, guest or invitee) shall be the sole responsibility and liability of said Unit Owner.

H. Additionally this Fifth Amendment shall amend the Declaration to clarify what kinds of insurance coverage a Unit Owner must obtain and maintain on their Unit, and the types and amounts of coverage required by contractors or other vendors servicing Units.

H. Additionally, this Fifth Amendment shall amend the Bylaws to create an Individual Assessment to help carry out the purposes of the Declaration Amendment.

I. Additionally, this Fifth Amendment shall amend the Bylaws pursuant to the Utah Condominium Ownership Act to give the Management Committee authority to regulate or prohibit smoking in the Common Areas and buildings of the Association.

NOW THEREFORE, the foregoing recitals are incorporated herein by reference and the Association does hereby declare as follows:

1. Section 15 of the Declaration is hereby amended by adding the following clarification:

"Any damage to the Property, including without limitation to any other Unit or the Common Area or facilities, caused by a Unit Owner (or his family, tenant, guest or invitee) or resulting from the failure of such Unit Owner (or his tenant, family, guest or invitee) to properly maintain his or her Unit in accordance with, or to strictly observe the requirements of the Declaration, Bylaws, Rules and Regulations or other applicable laws, rules or ordinances shall be the sole responsibility and liability of said Unit Owner. To the extent that any such damage must be repaired by the Association or any other Unit Owner, the Association is hereby authorized to assess such repair costs against the offending Unit and collect such assessment as provided for in this Declaration."

2. Section 21(e) of the Declaration shall be amended in its entirety to read as follows:

"Each Owner shall obtain and maintain the following types of insurance coverages:

- Public Liability Insurance. Each Owner will obtain public liability insurance for his Lot and shall provide the Association with a Certificate of Insurance upon request;
- Building Coverage (inside the unit) Each Owner shall have a minimum amount of \$10,000 for Building coverage added to his individual owner's policy;

Loss Assessment. Each Owner shall have a minimum amount of \$20,000 for loss assessment coverage added to his Living Unit;

Premium. The insurance premium on the Owner's policy shall be paid by the Owner.

Maintenance of Coverage. The Owner shall obtain and keep in full force and effect at all times the required insurance coverage provided by companies duly authorized to do business in Utah.

Not a Limitation. The provisions of this subsection shall not be construed to limit the power or authority of the Owner to obtain and maintain insurance coverage in addition to any insurance coverage required hereunder, in such amounts and in such forms as he may deem appropriate.

Default. If an Owner fails to maintain the required insurance or fails to provide a Certificate of Insurance within three (3) days of a request, and fails to remedy a default within ten (10) days of written notice, the Association may but is not obligated to, without further notice, purchase the required insurance and treat the cost as an Individual Assessment.

Contents. The Association Master Policy DOES NOT cover the contents of the Living Unit or the personal property of the Unit or Resident such as automobiles, furniture, furnishings, appliances, paintings, pictures, wall hangings, clothing, personal belongings and effects, and other contents, or personal liability.”

3. Section 21A of the Declaration shall be added and shall read as follows:

“All property management companies and/or contractors conducting property management or construction services for Unit Owners, must provide evidence to the Association of liability insurance and workers compensation insurance prior to commencing work for the Unit Owner. If the period of service by the management company or contractor expands beyond one policy period, the management company or contractor shall submit adequate proof of insurance to the Association at the beginning of each insurance renewal period. The Association must be endorsed or listed as an additional insured or interested party on the policy. Failure to provide proper proof of insurance may result in a stop work order from the Association, fines or a lawsuit, the costs of which will be an Individual Assessment.”

4. Article VI(A)(8) of the Bylaws shall be added and shall read as follows:

“Any expenses benefiting or attributable to fewer than all of the Units may be assessed exclusively against the Units affected or benefited (“Individual Assessment”). Individual Assessments shall include, but are not limited to:

(a) Assessments levied against any Unit to reimburse the Association for costs incurred in bringing the Unit or its Owner into compliance with the provisions of the Declaration, Bylaws, or rules and regulations of the Association and for fines or other charges imposed for violation of this Declaration, the Bylaws or any rules and regulations of the Association.

(b) Any reasonable services provided to a Unit by the Association due to an Owner's failure to maintain the same in order to protect the health, safety and welfare of the Owners and the Association in general.

(c) Any utility, data, entertainment, or communication service provided to a Unit by the Association or other service providers authorized by the Association, pursuant to a contract or other agreement, to provide services to Owners.

(d) Any other cost, expense, or penalty attributable to an individual Unit or group of Units.”

5. Article VIII, first paragraph of the Bylaws shall be amended in its entirety to read as follows, the remainder of Article VIII to remain the same:

“Any Unit Owner who rents or leases their Unit shall file a written lease agreement with the Association. Any Unit Owner renting or leasing their Unit for more than thirty (30) consecutive days to a tenant shall use the Association's Approved Lease Agreement, which may be obtained from the Management Committee. The provisions of Article VII shall apply equally to renters and/or tenants.”

5. Article XIX of the Bylaws shall be added and shall read as follows:

“Smoking on the Common Areas within 25 feet of any building is strictly prohibited. Smoking in the Units shall be governed by Utah law.”

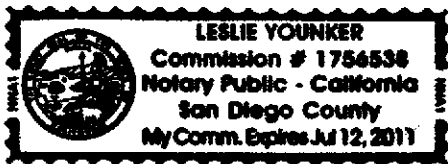
