RESIDENTIAL AREA COVENANTS

No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single-family dwelling, or one-half of an attached twin home structure not to exceed two stories in height and private garages and /or carports for not more than three vehicles. All contruction to be of new materials, except that used brick may be used with prior written approval of the Architectural Control Committee.

 2. Architectural Control. No building shall be erected, placed, or altered on any lot until the construction plans and specifications and a plan showing the location of the structure have been approved by the Architectural Control Committee as to quality of workmapship and materials, harmony of external design with existing structures, and as

No animals, livestock, or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose and are restricted to the owner's premises or on leash under handlor's control.
- 11. Garbage and Refuse Disposal. No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other waste shall not be kept except in sanitary containers. - 2. Should said party wall be damaged or destroyed by any cause other than the act or negligence of the other party, the same shall be rebuilt or repaired to a condition equal to or better than immediately prior to its being damaged, at the joint expense of both parties, provided that any sum received by insurance against such damage or destruction shall be first applied to such restoration.
