**EASEMENT**


**COMMUNITY HOUSING SERVICES-WRIGHT VILLA, INC.**, a Utah corporation, as **GRANTOR**, 1059 East 900 South, Salt Lake City, County of Salt Lake, State of Utah, hereby grants, bargains, sells, and conveys to **WILLOW PARK ASSOCIATES, LLC**, a Utah limited liability company, 756 South 200 East, Suite A, Salt Lake City, County of Salt Lake, State of Utah, as **GRANTEE**, for the sum of TEN DOLLARS AND OTHER VALUABLE CONSIDERATION, the sufficiency and receipt of which is hereby acknowledged, a non-exclusive easement, fifteen (15) feet in width, seven and one-half (7.5) feet on each side of that centerline located upon the Grantor's property which centerline is more particularly described on Exhibit "A" attached hereto and incorporated herein by reference, for the construction, maintenance, operation, repair and replacement, solely at Grantee's expense, of a sanitary sewer outfall line and necessary components thereof; as the same may exist from time to time. Such non-exclusive easement shall be for the benefit of Grantee and its successors and assigns but shall be limited to and for the exclusive benefit of that certain real property described on Exhibit "B" attached hereto and incorporated herein by reference.

After installation of the Grantee's sanitary sewer outfall line, Grantee shall restore Grantor's property to its prior condition, such restoration at Grantee's sole cost and expense.

The Grantor, or its successor and assigns, as owner of the real property through which such easement passes shall have the right, upon advance written notice to Grantee, to relocate such sanitary sewer outfall line and necessary components, at Grantor's expense, provided that such relocation shall not unreasonably interfere with or diminish any use to the property which such easement serves. If requested by either party, or their successors, such relocation shall be evidenced by an instrument executed by Grantor and Grantee (or their respective successors) and recorded in the offices of the Salt Lake County Recorder.

IN WITNESS WHEREOF, Grantor has caused this instrument to be signed in its name by a duly authorized manager this 20 day of May, 2003.

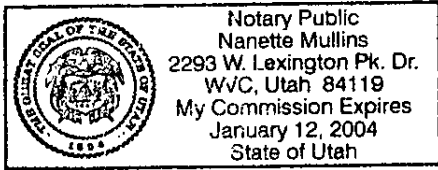
