DECLARATION OF PROTECTIVE COVENANTS AND RESTRICTIONS APPLYING TO UNIVERSITY GARDENS SUBDIVISION, PLAT B, PROVO, CITY, UTAH

WHEREAS, it is proposed to set up an area of land hereinafter described for a residential district, and

WHEREAS, it is proposed that said district and section of land shall have a protective covenant applying to and running with said land, and binding upon all parties, their heirs, successors and assigns.

NOW, THEREFORE: The signer hereto in consideration of their mutual promises and in consideration of covenants herein made do severally agree to and with each other as to the following described property:

Commencing 10.47 chains South of the Northeast corner of Section 6, Township 7 South, Range 3 East of the Salt Lake Base and Meridian; thence North 89° West 1162.26 feet; South 1° West 604 feet; South 89° East 638.6 feet; South 1° West 82.5 feet; South 89° East 535.64 feet; North 686.5 feet to beginning. Area 17.20 acres.

These covenants are to run with the land and shall be binding on all parties and all persons claiming under them until January, 1969, at which time said covenants shall be automatically extended for successive periods of 10 years unless by vote of a majority of the then owners of the lots it is agreed to change said covenants in whole or in part.

If the parties hereto, or any of them or their heirs or assigns, shall violate or attempt to violate any of the covenants herein it shall be lawful for any other person or persons owning any real property situated in said development or subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant and either to prevent him or them from doing so or to recover damages or other dues for such violation.

Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.

A All lots in the tract shall be known and described as residential lots. No structures shall be erected, altered, placed, or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed one story in height and a private garage for not more than 2 cars.

B No building shall be erected, placed, or altered on any building plot in this subdivision until the building plans, specifications, and plot plan showing the location of such buildings have been approved in writing as to conformity and harmony of external design with existing structures in the subdivision, and as to location of the building with respect to topography and finished ground elevation, by a committee composed of George S. Ballif, Mark D. Eggertsen and Dennis B. Wheeler, or by a representative designated by a majority of the members of said committee. In the event of death or resignation of any member of said committee, the remaining member, or members, shall have full authority to approve or disapprove such design and location, or to designate a representative with like authority. In the event said committee, or its designated representative, fails to approve or disapprove such design and location within 30 days after said plans and specifications have been submitted to it or, in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this covenant will be deemed to have been fully complied with. Neither the members of such committee, nor its designated representative shall be entitled to any compensation for services performed pursuant to this covenant. The powers and duties of such committee, and of its designated representative shall cease on and after January 1, 1950. Thereafter the approval described in the covenant shall not be required unless, prior to said date and effective thereon, a

written instrument shall be executed by the then record owners of a majority of the lots in this subdivision and duly recorded appointing representative, or representatives, who shall thereafter exercise the same powers previously exercised by said committee.

C No Building shall be located on any residential building plot nearer than 23 feet to the front lot line, nor nearer than 25 feet to any side street line. No building except a detached garage or other outbuildings located 60 feet or more from the front lot line, shall be located nearer than 6 feet to any side lot line.

D No residential structure shall be erected or placed on any building
