UTAH LIME & CRIMET COMPANY, a corporation organized and existing under the laws of the State of Utah, with its principal office at Salt Lake City, County of Salt Lake, State of Utah, grantor hereby Quit Claims to HAMBERGER RAILROAD COMPANY, grantee of Salt Lake City, Utah for the sum of One and no/100 (\$1.00) Dollars, the following described tract of land in Salt Lake County, State of Utah:

A right of way 35 feet wide, the center line of which and the center line of the track begins on the east side of Beck Street at a point approximately 537,5 feet East and 835.5 feet S 43051: Bast from the NW Corner of Section 25, Tp. IN, Rge. IW, Salt Lake Meridian, (which point is further described as being N 58009' E 60.8 feet from a Salt Lake City Street Monument located N 43051' W 1151 feet from the Salt Lake City Street Monument at the intersection of Beck and Columbus Streets); and running thence S. 79014' East 832 feet; thence on a curve to the right with a radius of 308 feet 224 feet; thence S . 37026' East 117 feet; thence on a curve to the right with a radius of 319.6 feet, 376 feet to the Northerly end line of the Associated 011 & Gas Company property.
