WHEREAS, a number of the citizens who own property on 100 East (also known as Canyon Road) between 2320 North and 2836 North have historically utilized septic systems; and WHEREAS, septic systems are disfavored over sewer connections for a variety of reasons; and

WHEREAS, neighborhood meetings regarding the installation of a sewer main in 100 East were held on October 11, 2017 and November 15, 2017 and many citizens along the impacted area of 100 East stated their interest in having a sewer main and associated private sewer laterals installed; and

WHEREAS, Utah County designed and constructed the Canyon Road Reconstruction and Widening project beginning in 2017 and completing the project in 2020; and

WHEREAS, City determined in November of 2017 that it is in the best interests of the citizens to design and install a sewer system to serve the residents on 100 East between 2320 North and 2836 North in coordination with said Utah County project; and

WHEREAS, City has constructed and paid for said sewer infrastructure including a sewer main line and laterals; and

WHEREAS, City has stubbed a sewer main or lateral to the parcels included in this notice; and

WHEREAS, City determined that it is fair and reasonable for those citizens receiving the benefit of said sewer main line and laterals to pay for a portion of the costs of installing the sewer improvements; and

WHEREAS, City is entitled to be reimbursed by those individuals, corporations or other entities who shall benefit from the sewer infrastructure installation at the time that a connection to the City's sewer system is requested;

WHEREAS, it is anticipated that there will be future service lateral connections on some properties served by the sewer main that have not been installed with the 100 East project and therefore they do not receive equal benefit as those who have a complete stubbed sewer lateral, and the City therefore deems that those that have to install their own laterals should not have an equal share of the cost;

NOW THEREFORE, in consideration of the completion of the installation of the sewer infrastructure in 100 East, the following applies to each property that now has access to the City's sewer system:

- City has installed and will operate and maintain a sewer system in 100 East between the addresses of 2320 North and 2836 North according to the standard specifications of Pleasant Grove City and as shown in Exhibit A.
- 2. City has paid \$319,590 for costs associated with the installation of the sewer system in 100 East, including, but not limited to, engineering, design, inspection, road repair, and construction costs.
- 3. City has estimated a total number of services, both existing and future, to be 19. This brings the average cost per service connection to be \$16,820.
- 4. On November 10, 2020, a city council meeting was held wherein the city council agreed that an 83.70% reduction would be given to all existing homes when they connect to the stubbed sewer lateral for their home. See existing homes labeled on Exhibit A.

- 5. For an existing home, in addition to the typical City and Timpanogos Special Service District impact fees for a new service connection, as determined at the time of connection request, properties with existing homes shall be obligated to pay an additional \$2,740, approximately 16.30% of the proportionate share of the costs of installing said sewer main system.
- 6. A future new lot created through the subdivision process that will be receiving service from the 100 East sewer system and has a stubbed **sewer lateral** for the new lot shall pay the full cost of the proportionate share of the project per connection based on the total number of estimated connections to be served by the aforementioned sewer system. There is one lateral that was installed on the system which is considered to have a full share responsibility. Based on an equal distribution among the 19 full shares the complete price per equivalent full share is \$16,820. This cost may be paid in full at time of connection request for the new lot.
- 7. A future new lot created through the subdivision process that will be receiving service from the 100 East sewer system and has a stubbed **sewer main** to the property for multiple new lots shall pay 50% of the full cost of the proportionate share of the project per connection based on the total number of estimated connections to be served by the aforementioned sewer system. There is one sewer main that was installed to a property in order to serve a future development area on the system that is anticipated to have approximately 6 future lots. Based on an equal distribution among the 19 full shares, the complete price per equivalent full share is \$16,820. New lots, regardless of the number of new lots, under this premise shall pay 50% of an equivalent full share, or \$8410, at time of connection request for the new lot.

8. Property Owners shall be responsible for the installation and costs of their individual laterals or sewer collection systems beyond what stubs may already be installed as part of the sewer system without City participation.


