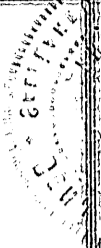

a channel change for a canal and appurtenant parts thereof:

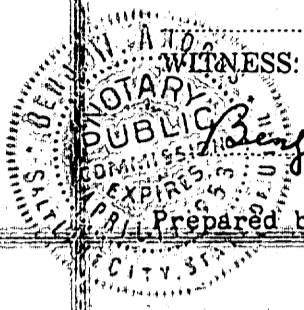
A parcel of land adjoining westerly the westerly right of way line of highway known as Project No. F-37. The boundaries of said parcel of land are described as follows:

Beginning at a point on said right of way line opposite Engineer's Station 32+21 of the center line of survey of said project, which point is approximately 512 feet North and approximately 80 feet East from the SW corner of said NE 1/4 SW 1/4; thence S. 88°16' W., 50 feet; thence South 53 feet, more or less, to the center of said canal; thence Northeasterly 54 feet, more or less, along said center of canal to said right of way line; thence Northerly 34 feet, more or less, along said right of way line to the point of beginning. The above described parcel of land contains 0.05 acre, more or less.
