These Covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty years from the date these Covenants are recorded, after which time, said Covenants shall be automatically extended for successive periods of ten years unless an instrument signed by a majority of the then-owners of the lots has been recorded changing said Covenants in whole or in part.

6. The foregoing language is admittedly somewhat ambiguous with regard to the time within which the owners may modify or

otherwise change the Covenants. In drafting the applicable language, it was the intent of the developer to extend to a majority of the owners of the lots the right to change the Covenants, in whole or in part, at any time subsequent to the recordation of the Covenants.
