ORDINANCE NO. 05-06

AN ORDINANCE APPROVING AN AMENDMENT TO THE CENTRAL BUSINESS DISTRICT NEIGHBORHOOD DEVELOPMENT PLAN ADOPTED IN 1977, AMENDED IN 1982 AND 1999, TO DELETE A PORTION OF THE PROJECT AREA.

## PREAMBLE

The Redevelopment Agency of Murray City (the "RDA") adopted the Central Business District Neighborhood Development Plan in 1977 (the "C.B.D. RDA"). The RDA amended the C.B.D. RDA in 1982 and 1999.

The RDA, on January 18, 2005, adopted findings of blight for the proposed redevelopment project area known as the Fireclay Survey Area ("Fireclay RDA"). Included in the Fireclay RDA is an area located in the C.B.D. RDA. The RDA amended the C.B.D. RDA Plan to delete a part of the project area because it is no longer necessary or desirable to the C.B.D. Project Plan and so it may be included in the Fireclay RDA. The proposed C.B.D. RDA Area after deleting a portion that will be included in the Fireclay RDA is provided in Appendix "A". The amendment does not propose to enlarge the C.B.D. RDA project area or permit the RDA to receive, from any taxing entity, a greater percentage of tax increment or to receive tax increment for a longer time.

UTAH CODE ANN. Section 17B-4-411(5) states that the amendment adopted by the RDA may not take effect until it is approved by the legislative body of the City. The Murray City Municipal Council, as the legislative body of the City, wants to approve the amendment to the C.B.D. RDA.

NOW BE IT ENACTED BY THE MURRAY CITY MUNICIPAL COUNCIL as follows:

Section 1. Purpose. The purpose of this ordinance is to approve the decision of the Redevelopment Agency of Murray City to amend the Central Business District Neighborhood Development Plan to delete a portion of its project area.

Section 2. Enactment. The Murray City Municipal Council hereby approves the decision by the Redevelopment Agency of Murray on January 18, 2005 to delete a portion of the Central Business District Neighborhood Development Plan area as described in Appendix "A".

Section 3. Effective date. This Ordinance shall take effect upon first publication.

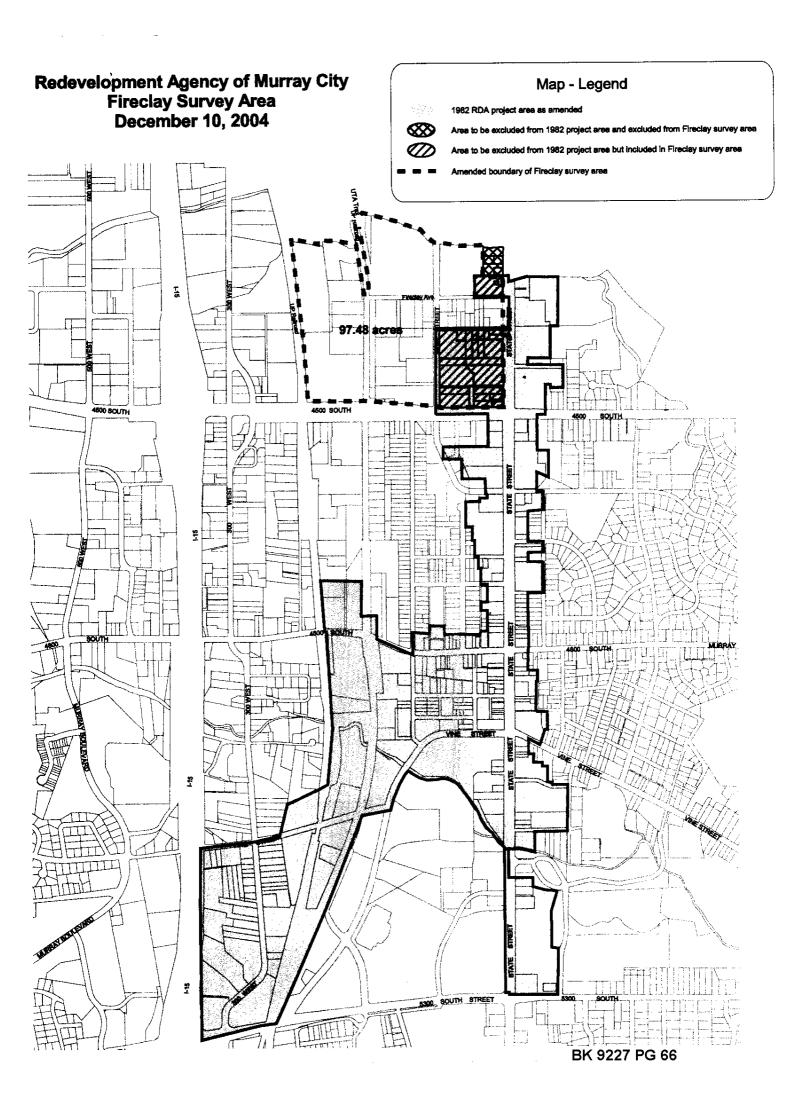

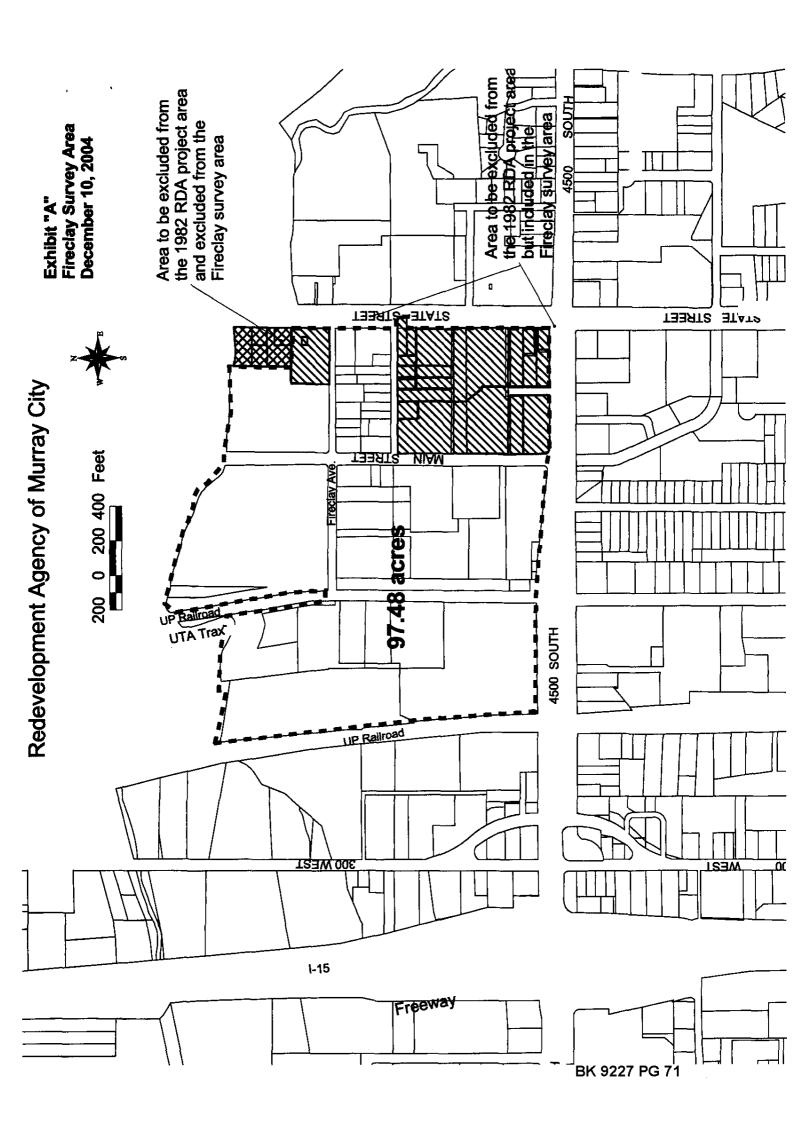
