WOODHOUSE AND CLARA JANE WOODHOUSE, GRANTORS, HEREBY CONVEY TO SALEM CITY CORPORATION, ITS SUCCESSORS IN INTEREST AND ASSIGNS, GRANTEE, A PERPETUAL EASEMENT AND RIGHT OF WAY FOR ERECTION AND CONTINUED MAINTENANCE, REPAIR, ALTERATIONS AND REPLACEMENT OF THE ELECTRIC TRANSMISSION AND DISTRIBUTION CIRCUITS OF THE GRANTEE WITH THE NECESSARY GUYS, STUBS, CROSSARMS AND OTHER ATTACHMENTS THERON, OR AFFIXED THERETO, FOR THE SUPPORT OF SAID CIRCUITS TO BE ERECTED AND MAINTAINED UPON AND THE PREMISES OF THE GRANTORS, IN UTAH COUNTY, UTAH, OVER THE FOLLOWING DESCRIBED PARCEL:

BEGINNING AT A POINT IN A FENCE ON THE EASTERLY LINE OF HIGHWAY 91, WHICH POINT LIES NORTH 545.98 FEET AND EAST 2023.69 FEET, ACCORDING TO UTAH COORDINATE BEARINGS, CENTRAL ZONE, FROM THE WEST ONE QUARTER CORNER OF SECTION 1, TOWNSHIP 9 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN; AND RUNNING THENCE NORTH 22°56'55" EAST ALONG SAID FENCE 654.35 FEET; THENCE SOUTH 87°15'00" EAST 10.66 FEET; THENCE SOUTH 22°56'55" WEST 654.20 FEET; THENCE NORTH 88°00'00" WEST 10.71 FEET TO THE POINT OF BEGINNING. (AREA = 0.150 ACRES)

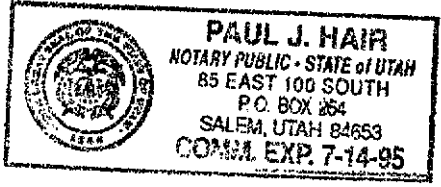
