

RESOLUTION OF THE SALT LAKE VALLEY FIRE SERVICE AREA APPROVING WITHDRAWAL FROM THE SALT LAKE COUNTY FIRE SERVICE AREA OF COTTONWOOD HEIGHTS CITY

BE IT KNOWN AND REMEMBERED:

WHEREAS, the Board of Trustees of the Salt Lake Valley Fire Service Area (District) convened a meeting duly noticed on September 29, 2005 (a copy of the notice is attached as Exhibit A); and

WHEREAS, the purpose of the meeting was to acknowledge and approve Cottonwood Heights City's request to withdraw from the Salt Lake County Fire Service Area; and

WHEREAS, pursuant to Utah Code Ann., § 17B-2-601(3), Cottonwood Heights City automatically withdrew from the District when it adopted a resolution approving said withdrawal which contains the legal description of the area to be withdrawn, and delivered a copy of said resolution to the Board of Trustees of the District, the receipt of which the Board of Trustees acknowledges; and

WHEREAS, Cottonwood Heights City delivered its adopted resolution for withdrawal which was acknowledged and approved by the Board on September 29, 2005, at a meeting duly noticed for said purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE SALT LAKE VALLEY FIRE SERVICE AREA AS FOLLOWS:

That the City's withdrawal from the District effective July 1, 2005, is hereby approved and be it further resolved that this resolution of approval is effective September 29, 2005.

RESOLUTION NO. 2005-46 A RESOLUTION APPROVING WITHDRAWAL FROM THE SALT LAKE COUNTY FIRE SERVICE AREA (A/K/A THE SALT LAKE COUNTY FIRE DISTRICT) EFFECTIVE 1 JULY 2005

WHEREAS, the city of Cottonwood Heights (the "City") was incorporated effective 14 January 2005; and

WHEREAS, prior to the City's incorporation, Salt Lake County, a county of the first class, created (without an election) a local district known as the "Salt Lake County Fire Service Area" (also known as the Salt Lake County Fire District) (the "District") to provide fire protection, paramedic and emergency services to unincorporated Salt Lake County, including, without limitation, the geographical area now included within the City; and

WHEREAS, UTAH CODE ANN. §17B-2-601(3) provides that the City is automatically withdrawn from the District if the City's governing body (the "Council") (a) adopts a resolution approving such withdrawal that includes the legal description of the area to be withdrawn; and (b) delivers a copy of such resolution to the board of trustees of the District; and

WHEREAS, on 7 June 2005, the Council met in regular session to consider, among other things, whether to approve the City's withdrawal from the District; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve the City's withdrawal from the District effective 1 July 2005;

NOW, THEREFORE, BE IT RESOLVED by the Cottonwood Heights city council that the City's withdrawal from the District effective 1 July 2005 is hereby approved; and

FURTHER RESOLVED that such withdrawal shall be effective for the entire geographical area of the City described on the attached exhibit; and


FURTHER RESOLVED that the City's recorder is authorized and directed to immediately deliver a copy of this resolution to the District's board of trustees or other governing body.

CITY OF COTTONWOOD HEIGHT INCORPORATION LEGAL DESCRIPTION

A parcel of land located in Sections 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 33, 34, 35, and 36 in Township 2 South, Range 1 East, Salt Lake Base and Meridian, and Sections 1 and 2 in Township 3 South, Range 1 East, Salt Lake Base and Meridian, more particularly described as follows:

RESOLUTION NO 1 3A

AMENDMENT No. 2005-3 To The

Cooperative Agreement by Public Agencies
To Create a New Entity to Consolidate Fire Protection, Emergency Medical and
Emergency Protection Services and Provide Rules of Governance

WITNESSETH:

WHEREAS, the Legislature of the State of Utah has provided in Title 11, Chapter 13 of Utah Code Ann. (1953, as amended), that any two or more public agencies may enter into agreements with one another for joint or cooperative action following the adoption of an appropriate resolution by the governing body of each participating public agency prior to such agreement entering into force; and

WHEREAS, Salt Lake County (now Salt Lake Valley Fire Service Area), and the cities of Taylorsville, Holladay, Riverton, Draper and Herriman and the Town of Alta have entered into a Cooperative Agreement ("Agreement") effective January 1, 2004; and

WHEREAS, the parties to the Agreement wish to amend certain provisions to the Agreement; and

WHEREAS, paragraph 22(a) to the Agreement provides that the Agreement may, by majority vote of the Board, be amended to admit additional members; and

WHEREAS, on the 21st day of June, 2005, a majority of the Board voted to admit the city of Cottonwood Heights as a member of the Unified Fire Authority;

WHEREAS, paragraph 22(a) provides that promptly upon admission, all of the then Members (including such new Member) shall mutually execute and deliver an amendment to this Agreement adding such new Member as one of the parties to this

Agreement.

NOW THEREFORE, the Agreement is hereby amended as follows:

1. The introductory paragraph is amended to read:

THIS COOPERATIVE AGREEMENT BY PUBLIC AGENCIES TO CREATE A NEW ENTITY TO PROVIDE FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES AND RULES OF GOVERNANCE (this AAgreement@) is entered into effective January 1, 2004, by and among SALT LAKE COUNTY, a body corporate and politic (the ACounty®), CITY OF TAYLORSVILLE, a municipal corporation and political subdivision of the State of Utah (ATaylorsville®), CITY OF HOLLADAY, a municipal corporation and political subdivision of the State of Utah (AHolladaye), RIVERTON CITY, a municipal corporation and political subdivision of the State of Utah (ARiverton®), CITY OF DRAPER, a municipal corporation and political subdivision of the State of Utah (ADraper@), HERRIMAN, a municipal corporation and political subdivision of the State of Utah (AHerriman@), **COTTONWOOD HEIGHTS,** a municipal corporation and political subdivision of the State of Utah (ACottonwood Heights@), and TOWN OF ALTA, a municipal corporation and political subdivision of the State of Utah (AAlta@). In this Agreement, Taylorsville, Holladay, Riverton, Draper, Herriman, Cottonwood Heights, and Alta are collectively referred to as the ACities@ or individually as the ACity, @ and the County, Taylorsville, Holladay, Riverton, Draper, Cottonwood Heights, and Herriman are collectively referred to as the AMembers. @ The AMembers@ also shall include each and every other body corporate and politic that hereafter (a) becomes one of the Members by operation of law: or (b) is admitted as an additional Member as described in section 22 below.
