HIGHLAND DRIVE TRAIL EASEMENT

Summit County, a political subdivision of the State of Utah, having a mailing address of 60 N. Main, P.O. Box 128, Coalville, Utah 84017, Grantor, does hereby grant and convey to the Snyderville Basin Special Recreation District, a special service district of the State of Utah, having a mailing address of 5715 Trailside Drive, Park City, Utah 84098, Grantee, its successors and assigns, for the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, a perpetual, non-exclusive right of way and easement twenty (20) feet in width to construct, maintain, operate, repair, inspect and protect a detached, non-motorized trail (hereafter the "Highland Drive Trail"), at its sole cost and expense, over, under, through and across the following described land in Summit County, State of Utah (hereafter the "Easement Property"):

See property description in Exhibit "A" attached hereto and incorporated herein by reference

TO HAVE AND TO HOLD the same unto the said Grantee, its successors and assigns, with the right of ingress and egress to and from said right of way and easement to construct, maintain, operate, repair, inspect and protect the same. During temporary periods, Grantee may use such portion of the land adjoining said Easement Property as may be reasonably necessary in connection with the construction, maintenance, operation, repair, inspection and protection of the right of way, easement and Highland Drive Trail. The Grantor shall have the right to use the said premises except for the purposes for which the Highland Drive Trail is granted to the said Grantee, provided such use does not interfere with the Highland Drive Trail or any other rights granted to the Grantee hereunder.

All activities by the Grantee with respect to the right of way and easement granted herein shall be pursued diligently to completion and Grantee shall in all instances maintain the Highland Drive Trail, which maintenance shall include, but shall not be limited to sweeping, snow plowing, weed spraying, crack sealing, seal coating, and otherwise keeping the trail in a serviceable and safe condition.

Grantee shall use best efforts to avoid any lien or claim of mechanics, laborers or materialmen to be filed against the Easement Property, or any part or parts thereof, for any work, labor or materials furnished, alleged to have been furnished or to be furnished pursuant to any agreement by Grantee. Notwithstanding, in the event a lien or claim is filed, Grantee shall

within thirty (30) days after the date of the filing or recording of any such lien, take the necessary actions to have the lien discharged of record, or, if Grantee contests the amount allegedly due or the right of the lienor to make its lien claim, Grantee shall cause a bond for at least 150% of the amount of the disputed lien claim to be issued in favor of Grantor to protect Grantor from any damage resulting from the lien during the entire time of any proceeding in which Grantee contests the lien.

Grantee shall have a right of ingress and egress to and from the Easement Property across those portions of the real property owned by Grantor that are contiguous to the Easement Property and which are reasonably required to gain access to the Easement Property. Provided, however, Grantor reserves the right to construct improvements on any and all such property at its sole discretion and without the consent of Grantee so long as Grantee has reasonable access to the Easement Property in order to use the right of way and easement in accordance with the provisions hereof.

Grantor reserves unto itself forever, the right to cross over or under said Highland Drive Trail, to place or grant other easements along or across said Easement Property so long as such other uses do not prevent Grantee's use of the Highland Drive Trail for the limited purposes herein granted.

The Grantor shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way and easement nor change the contour thereof without written consent of the Grantee. This restriction does not prohibit the installation of normal pavement, curb and gutter, curb cuts, driveways and grass and other types of ground cover on the surface of the Easement Property as part of the future improvement of Grantor's land.

Grantee acknowledges that Grantor has no obligations with respect to the preparation or maintenance of the Highland Drive Trail, and Grantee waives all claims against Grantor with respect thereto except for any claims arising from or relating to the intentional or negligent acts or omissions of the Grantor or its officers, directors, owners, agents, representatives, affiliates, partners, associates and employees.

Further, Grantee indemnifies and holds the Grantor, its officers, directors, owners, agents, representatives, affiliates, partners, associates and employees harmless from any and all claims, suits, actions, damages and costs of every name and description arising out of, or resulting from, the construction, maintenance and use of the Highland Drive Trail.

This right of way and easement grant shall be binding upon and inure to the benefit of the successors and assigns of the Grantor and the successors and assigns of the Grantee.

This right of way and easement grant may be assigned in whole or in part by Grantee with the prior written consent of the Grantor, which consent shall not be unreasonably withheld.

The term "Grantor" as used herein shall mean only the owner or owners of the fee title to

the Easement Property at the time in question and in the event of any transfer of such title or interest, the Grantor herein named (and in case of any subsequent transfers, the then Grantor) shall be relieved from and after the date of such transfer of all liability as respects Grantor's obligations, if any, thereafter to be performed. The obligations contained in this Highland Drive Trail Easement to be performed by Grantor, shall, subject as aforesaid, be binding upon Grantor's successors and assigns, only during their respective periods of ownership.

It is hereby understood that this Highland Drive Trail Easement constitutes the entire understanding and agreement between the parties, and supersedes any previous agreement, representation, or understanding between the parties relating to the subject matter hereof.


