AN ORDINANCE VACATING ALLEYS  
in Blocks 5, 9, 15, 16 and 17, Clermont  
Subdivision, Section 28, T. 1 S., R. 1  
E., Salt Lake Base & Meridian.

Do it ordained by the Board of Commis-  
sioners of Salt Lake City, Utah:

SECTION 1. That alleys in Blocks  
5, 9, 15, 16 and 17, Clermont Subdi-  
vision, Section 28, T. 1 S., R. 1 E., Salt  
Lake Base & Meridian, more particu-  
larly described as follows:

inhabitants of Salt Lake City that this  
ordinance become effective immedi-  
ately.

SECTION 3. This ordinance shall take  
effect upon its first publication.
