**AMENDED DECREE OF DIVORCE**

The above-entitled matter came before the court for trial on May 14 and 15, 2015, pursuant to notice. Petitioner was present and represented by her counsel, Ellen Maycock. Respondent was present and represented by his counsel, Rodney Parker. The Honorable Paul B. Parker presided. The court held a further hearing on August 28, 2015. The court having heard the testimony of witnesses, received exhibits and heard arguments of counsel, and having made and entered its findings of fact and conclusions of law:

**NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:**

1. **Divorce.** Petitioner is granted a decree of divorce on the grounds of irreconcilable differences to become final upon entry.
2. **Children.** The parties have two children as issue of their marriage, a son, D.K.A., born November 1999, and a daughter, K.V.A., born December 2001.
3. **Custody and Parent-time.** The parties are awarded joint legal custody of their children, with petitioner to have primary physical custody and respondent to have parent-time as the parties agree, but at a minimum at least in accordance with *Utah Code Ann.* §30-3-35 and the parenting plan dated September 11, 2015.
4. Petitioner may not relocate outside the Salt Lake Valley with the children without express permission of the court.
5. **Child Support.** Respondent is ordered to pay child support to petitioner in the amount of \$3,791 per month beginning September 15, 2015. Child support shall continue for each child until that child reaches the age of 18 or graduates from high school in his or her normal and expected year, whichever occurs last.
6. **Medical Insurance and Expenses.** Respondent shall continue to maintain medical insurance for the benefit of the parties' minor children. Each party is ordered to pay one-half of the out-of-pocket costs of the premium attributable to the children and one-half of all uninsured medical, dental, orthodontic, optical and psychotherapeutic expenses incurred for the benefit of the minor children.
7. **Alimony.** Respondent is ordered to pay alimony to petitioner in the amount of \$5,000 per month beginning September 15, 2015. Total alimony and child support for September 2015

is \$6,956. Alimony will continue for the duration of the marriage, except that alimony will terminate earlier upon petitioner's remarriage, cohabitation, or either party's death.

8. **Property Division.**

a. The property of the parties shall be divided in accordance with Exhibit "A" attached hereto. Petitioner is awarded the proceeds of the sale of the marital residence. Respondent is awarded his shares of Sentinel Security Life Insurance Company stock returned to the company. The remaining assets of the parties are awarded as set forth in Exhibit "A."

d. Bank Accounts. The parties' bank accounts will be divided as set forth on Exhibit "A."

e. Retirement Accounts. Respondent's Great West Financial Retirement Services account should be divided equally as of the date of entry of the decree of divorce. Respondent's pension with Utah Retirement Systems should also be divided equally as of the date of entry of the decree of divorce. Petitioner is awarded her 401k account from her employment with Nordstrom in the amount of \$1,875. Half of the value of that account will be deducted from the division of the Great West Financial Retirement Services account. The parties are ordered to cooperate implementing Qualified Domestic Relations Orders as necessary to divide the accounts.

f. Camper. The 2011 Springdale camper is awarded to respondent and he should assume and pay the obligation associated with the camper.

g. Personal Property. Each party should be awarded the furniture and personal property currently in his or her possession.

h. Vehicles. Each party is awarded the vehicle he or she currently drives and pay the

obligations thereon. Respondent is awarded the Harley Davidson he purchased after separation and should pay the obligation thereon.

1. **Property Equalization.** Pursuant to Exhibit "A" attached hereto, respondent owes petitioner \$31,154.02 to equalize the property division. Respondent is ordered to pay that amount on or before March 31, 2016. If he fails to do so, petitioner is entitled to entry of a judgment for that amount.
2. **Skymiles/Award Points.** Respondent's Skymiles are divided 46,462 to petitioner and 88,962 to respondent. The Marriott points shall be divided equally between the parties.
3. **Debts and Obligations.** Each party shall pay any debts and obligations they have incurred during their separation. Respondent is ordered to pay the Harley Davidson debt, the camper debt, his student loans and the debt to Sentinel Security Life Insurance Company. Petitioner is ordered to pay the debt to her father and her credit cards.
4. **Life Insurance.** Respondent is ordered to maintain a life insurance policy with a death benefit adequate to pay his alimony and child support obligations to petitioner, naming petitioner as beneficiary, so long as he has an alimony or child support obligation to her.
5. **Taxes.** The parties are ordered to file joint income tax returns for 2014. The parties shall divide equally any refunds or additional tax obligations.
6. **Tax Exemptions.** Each party is entitled to claim the tax exemption for one of the parties' minor children. Petitioner is allowed to claim K.V.A. and respondent is entitled claim D.K.A. In the event that the tax exemption provides no benefit to respondent, he shall allow petitioner to claim it.
7. **Children's Savings Accounts.** The children's savings accounts are not marital property. Each of the parties shall administer the account as to which he or she is trustee since they

were gifted to the children by their grandparents.

8. **Maiden Name.** Petitioner is restored to her maiden name of Amy Volcic, if she chooses.

9. **Attorneys' Fees and Costs.** The court will enter a separate order with respect to attorneys' fees.

10. **Cooperation.** Petitioner and respondent shall cooperate in clearing title or transferring assets to accomplish the purposes and intent of this decree of divorce. Each party should execute any and all documents necessary to carry out the terms of the decree of divorce immediately upon execution and/or entry of the same.
