The United States of America, to all to whom these presents shall come, greeting: Whereas, there has been deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at Salt Lake City, Utah Territory, whereby it appears that, pursuant to the Act of Congress approved 20th May, 1862, "To secure Homesteads to actual settlers on the Public Domain," and the acts supplemental thereto, the claim of James D. Wilcox has been established and duly consummated, in conformity to law, for the South West quarter of the North West quarter and the North West quarter of the South West quarter of Section fourteen, in Township three North, of Range one West, in the District of Lands subject to sale at Salt Lake City, Utah Territory, containing eighty acres, according to the Official Plat of the Survey of the said Land, returned to the General Land Office

by the Surveyor General;

Now know ye, that there is therefore, granted by the United States unto the said James D. Wilcox the tract of Land above described; To have and to hold the said tract of Land, with the appurtenances thereof, unto the said James D. Wilcox and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law.

In testimony whereof, I, Rutherford B. Hayes, President of the United States of America, have caused these letters to be made Patent, and the Seal of the General Land Office to be hereunto affixed.

The United States of America, to all to whom these presents shall come, Greeting; Whereas, In pursuance of the Act of Congress, approved July 2, 1864, entitled "An Act donating Public Lands to the several States and Territories, which may provide Colleges for the benefit of Agriculture and the Mechanic Arts," there has been deposited in the General Land Office Scrip No 958, for one quarter section of Land, in favor of the State of Georgia, duly assigned by the proper authority of the said State to Stephen H.
