ORDER FOR FORMAL PROBATE OF ESTATE AND APPOINTMENT OF PERSONAL REPRESENTATIVE

This matter came before the Court on September 13, 2022 to address the competing applications of JoAnn King Smith ("JoAnn Smith") and Morris King to be appointed as personal representative of the estate of Stirling Forist King, Jr. (the "Deceased"). After hearing testimony and proffered testimony, the Court finds that between the competing applications, JoAnn Smith should be appointed as personal representative. Based upon the request of JoAnn Smith, Petitioner, to open formal probate of the estate of Stirling Forist King, Jr. and to appoint JoAnn Smith as personal representative, the Court makes the following findings and order.

FINDINGS

- 1. The Verified Petition of JoAnn Smith for formal probate of estate and for her appointment as personal representative appears to be complete and includes Petitioner's oath or affirmation that the statements are true to the best of the Petitioner's belief.
- 2. Petitioner is a person with an interest in the estate because she is a sibling (sister) of the Deceased.
- 3. The Deceased died on August 18, 2021. At least five full days have passed since the death.
- 4. This Court has jurisdiction and venue is proper in this court because Deceased resided in Salt Lake County at the time of his death.
- 5. The time for probate is within the required time period because not more than three years have passed since the Deceased died.
- 6. The Deceased died intestate.
- 7. No personal representative has been appointed by a court in Utah or any other state.
- 8. The Court finds that JoAnn Smith is at least 21 years old or older and has priority to serve because she is a sibling (sister of the Deceased) and no one has a higher priority.
- 9. Bond is not required.
- 10. Any notices required by the laws of Utah have been given.

11. The competing application of Morris King to be personal representative should be denied. JoAnn Smith has the majority of sibling support and backing and testimony has shown that ordering co-personal representatives in this matter would not be workable.

ORDER

The Court orders that:

- a. The Deceased's estate will be formally probated.
- b. JoAnn Smith is appointed the personal representative of the Deceased's estate to act without bond.
- c. Morris King's application for appointment as personal representative is denied.
- d. The Court will issue Letters of Administration to JoAnn Smith after she files her Acceptance of Appointment.
