A tract of land situate in the NE 1/4 of the SW 1/4 of Section 27, Township 5 North, Range 2 West, Salt Lake Meridian, described as follows:

Beginning at the northeast corner of the Grantors' land which is 330 feet east along the quarter section line from the northwest corner of the northeast quarter of the southwest quarter of Section 27, T. 5 N., R. 2 W., S.L.M. (said northwest corner being N. 89°59'21" E. 1323.36 feet from the west one quarter corner of said Section 27) and running thence West 81.05 feet along said quarter section line, thence S. 0°13'47" W. 278.00 feet to the south boundary line of said Grantors' land, thence East 82.16 feet along said south boundary line to the east boundary line of said Grantors' land, thence North 278.00 feet along said east boundary line to the point of beginning; containing 0.521 of an acre.

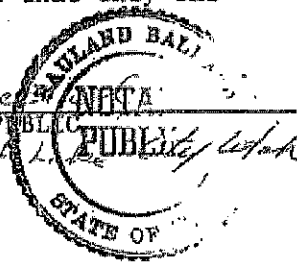
