ORDINANCE NO. 11-66 W Senularyh.

AN ORDINANCE OF OGDEN CITY, UTAH, CLOSING AND VACATING IOWA AVENUE FROM THE SOUTH LINE OF 19TH STREET SOUTH TO THE NORTH LINE OF 20TH STREET AND FROM THE SOUTH LINE OF 20TH STREET TO THE SOUTH LINE OF CITY VIEW ADDITION; AND CLOSING AND VACATING THAT CERTAIN PUBLIC ALLEY LOCATED IN BLOCK 1 OF CITY VIEW ADDITION, AND THAT CERTAIN PUBLIC ALLEY LOCATED IN BLOCK 2 OF CITY VIEW ADDITION, ALL IN OGDEN CITY AND QUIT CLAIMING THE LANDS EMBRACED THEREIN TO THE ABUTTING PROPERTY OWNERS. THEREIN TO THE ABUTTING PROPERTY OWNERS.
