



AMENDMENT AND RESTATEMENT

OF

THE FEIL-SULLIVAN LIVING FAMILY TRUST

(October Z 2015)

THIS AMENDMENT AND RESTATEMENT OF THE FEIL-SULLIVAN LIVING FAMILY TRUST (this "agreement"), dated this Z day of October, 2015, is between LANCE E. FEIL and CAROL S. SULLIVAN, husband and wife, as grantors (referred to in the first person plural), and LANCE E. FEIL and CAROL S. SULLIVAN, as trustees (referred to collectively as the "trustees").

Recitals

- A. By trust agreement dated March 27, 2001 (the "Trust Agreement"), we established The Feil-Sullivan Living Family Trust (the "Trust").
- B. Under Article 2.2 of the Trust Agreement, we expressly reserved the power to amend any terms of the Trust Agreement, in whole or in part.
- C. We now desire to exercise our reserved amendment power by amending the Trust Agreement in its entirety.

Amendment

THEREFORE, the Trust Agreement is hereby amended and restated to read in its entirety as follows:

ARTICLE 1: GOVERNANCE OF TRUST

- 1.01 **Trust Estate**. The trust estate is presently composed of the property described in the trust's books of account. The trustees shall administer and distribute such property in accordance with the provisions of this agreement.

Feil, of Swanzey, New Hampshire; and then (iv) Todd O. Sullivan, of League City, Texas.
- (b) <u>Appointment of Additional Trustees</u>. The trustees of a trust at any time may appoint one or more additional trustees of the trust by signed notice filed in the trust records and delivered to each appointed trustee and each beneficiary then eligible to receive trust income. The appointment may be for general or limited purposes and for a specified or indefinite term. The appointment shall be effective upon delivery of the notice of appointment to the appointed trustee or on such later date as may be specified in the notice.
- (c) <u>Resignation</u>. A trustee at any time may resign by signed notice filed in the trust records and delivered to each beneficiary then eligible to receive trust income. If the trustee is a co-trustee, the resignation shall be effective on the date the notice of resignation is filed in the trust records or on such later date as may be specified in the notice of resignation. If the trustee is the sole trustee, the resignation shall be effective on acceptance by a properly appointed alternate trustee.
- (d) <u>Incapacity</u>. A trustee shall be deemed to have resigned as of the date the trustee is determined to be incapacitated pursuant to the provisions of Article 7.03.
- (e) <u>Vacancies</u>. If a trustee fails to qualify or ceases to act and no alternate trustee is appointed under Article 5.01(a), an alternate trustee shall be appointed pursuant to the following methods, applied in the order of priority listed:
